2. Offer of financial support will only be made when Valuevest receives the actual results. (Academic Certificate validity is 2 years prior to application - year 2021/2022 except stated otherwise).
3. The financial supports starts from the month (12 months) upon receiving the offer letter from Valuevest Ventures, and not the year of application.
4. Incomplete or late submissions will not be accepted.
5. The financial support quantum awarded is in the form of cash award and will be given to the recipient by either cash or telegraphic transfer on a monthly basis.
6. In the event that the recipient withdraws from the programme, is suspended or terminated by the school at any point in time, before the completion of the programme, the financial support shall be automatically terminated. However, should the recipient withdraw from the programme due to the medical reasons, his/her financial support may be retained, subject to the absolute discretion of Valuevest Ventures, and only after the recipient has provided adequate supporting medical documents acceptable to Valuevest Ventures.
